Cremation services will have an additional fee for the Medical Examiner Fee established by the County Medical Examiner where the death occurred. Currently the Tarrant County Medical Examiner Fee is \$26 and the Dallas County Medical Examiner Fee is \$50. This fee is for their release for cremation. There will be a fee for Itemized Certificate of Death for the city or the county where the death occurred. The first certified copy is \$21 and each additional copy is \$3. There will be a fee for one copy for all services. You may also have additional fees for other items like newspaper notices, etc.
